

## FAS EYES ONLY SERIES

### SCOPE AND CONTENT

The FAS Eyes Only series of the Fred Seaton papers was evidently drawn together from Seaton's Defense Department, White House, and Interior Department files by his staff at the close of the Eisenhower administration. The material (approximately 10,000 pages) was placed in two cardboard boxes labeled "FAS Eyes Only." The only unifying element of the series is the fact that the documents therein (with a few exceptions such as speech outlines and research material) were either security classified or potentially sensitive or damaging to individuals.

The series has been divided into two subseries. The first subseries, approximately one-third of the series, deals with a miscellany of topics, predominantly investigations, personnel and budget matters, and cases involving government contracts. The remaining two-thirds of the series, the McCarthy subseries centers upon the Army's response to questions raised by the Permanent Investigation Subcommittee of the Senate Committee on Government Operations--the Army-McCarthy hearings. As Assistant Secretary of Defense for Legislative and Public Affairs Seaton worked as liaison between the Army and the White House in preparing the Army's case. Most of the papers in this subseries are working papers used in developing the case. Beginning with stenographic notes and memos kept by secretaries, memos for the record, and correspondence, Army officials evolved statements and chronologies to support their contentions in the matter of G. David Schine, Irving Peress, the Ft. Monmouth investigation, the question of loyalty-security board members appearing before congressional committees and other issues. Many of these working papers dealing with contacts between the Army and McCarthy or his staff, particularly Roy Cohn, were impounded in May of 1954, in the care of Fred Seaton, on the basis of executive privilege. Administrative memos dealing with this action are included in this subseries. Principal individuals involved from the Defense Department, besides Seaton, were Robert Stevens (Secretary of the Army), John G. Adams (Department Counselor), and H. Struve Hensel (Assistant Secretary of defense for International Security Affairs).

The folders and loose material in the first subseries were received unarranged. When necessary, folder titles were devised by a staff archivist. The folders were then arranged in alphabetical order. The McCarthy subseries was maintained in the order in which it was received. Here, too, some folder titles had to be devised.
